Through your much-needed donations, we will push for the election of public officials who support our entire nation's important Breast Cancer health bills.

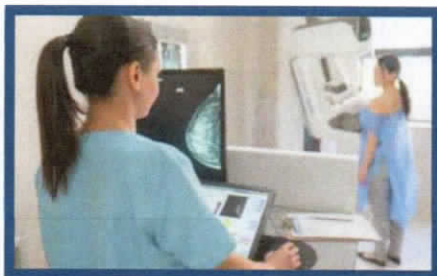
